An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluating the overall presentation of the financial statements.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

In our opinion, the financial statements referred to above present fairly, in all material respects, the financial position of The Bancroft School as of June 30, 2017 and 2016, and the changes in their net assets and their cash flows for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

1. Organization and Purpose

The Bancroft School (School), operating with the assumed corporate name The Winston Knolls Education Group, is a 501(c)(3) not-for-profit organization. The School operates a year-round nonpublic special education facility that services children ages three to sixteen with autism spectrum disorder and related learning and developmental disabilities. The School received approval from Illinois State Board of Education on April 29, 2015, to serve students ages three to nineteen in all its currently approved educational programs with the exception of its developmentally delayed educational program, which remains age three to nine. This ISBE approval includes serving students with an Intellectual Disability age three to nineteen. The School is located in Hoffman Estates, Illinois, and provides services to children in and around the Chicagoland area.

2. Summary of Significant Accounting Policies

Basis of Accounting – These financial statements, which are presented on the accrual basis of accounting, have been prepared to focus on the School as a whole to present balances and transactions according to the existence or absence of donor imposed restrictions. This has been accomplished by classification of net assets and transactions into three classes, if applicable: permanently restricted, temporarily restricted, and unrestricted.

Net assets and revenues, expenses, and gains and losses are classified based on the existence or absence of donor imposed restrictions. Accordingly, net assets and changes therein are classified as follows:

Permanently Restricted Net Assets – Net assets restricted by donors to be maintained by the School in perpetuity. The School has no permanently restricted net assets.

Temporarily Restricted Net Assets – Net assets subject to donor imposed stipulations that may or will be met by actions of the School or the passage of time. The School has no temporarily restricted net assets.

Unrestricted Net Assets – Net assets not subject to donor imposed stipulations.

Revenues are reported as increases in unrestricted net assets, unless use of the related assets is limited by donor imposed restrictions. Expenses are reported as decreases in unrestricted net assets. Gains and losses on investments and other assets or liabilities, as applicable, are reported as increases or decreases in unrestricted net assets, unless their use is restricted by explicit donor stipulation or by law. Expiration of temporary restrictions on net assets (i.e., the donor imposed stipulated purpose has been fulfilled, or the stipulated time period has elapsed) are reported as reclassifications between the applicable classes of net assets.

2. Summary of Significant Accounting Policies (cont'd)

Unconditional promises to give cash and other assets, as applicable, are reported at fair value at the date the promise is received. Conditional promises to give and indications of intentions to give are reported at fair value at the date the gift is received. Unrestricted gifts and bequests are included in revenues when received.

Contributions received with donor imposed restrictions that are met in the same year as received are reported as unrestricted revenues. This is true even when the promise to give and receipt occur during the same year.

Accounts Receivable – Accounts receivable primarily consist of amounts billed to local school districts for services provided up to June 30, 2017, based on a predetermined daily rate as approved by the Illinois Purchased Care Review Board. These receivables are unsecured and the School does not charge interest on amounts past due.

Management has determined that all accounts receivable are collectible at June 30, 2017. If management had determined that there were uncollectible accounts receivable, an allowance for doubtful accounts would have been established through a provision for bad debts charged to expense. Accounts are charged against the allowance for doubtful accounts when management believes collectability is unlikely. Management's periodic evaluation of the adequacy of the allowance is based on the School's past experience, known and inherent risks, adverse situations that may affect the customer's ability to repay, and current economic conditions. Past due status is based on contractual terms. All accounts receivable are less than ninety days past due at June 30, 2017.

Property and Equipment – Property and equipment are stated at cost or estimated value if donated. All acquisitions of property and equipment with a per-unit cost or estimated fair value if donated and all expenditures for repairs, maintenance renewals and betterments that materially prolong the useful lives of property and equipment in excess of \$500, are capitalized. Depreciation is computed on a straight-line basis over the estimated useful lives of the assets:

Property and Equipment (cont'd)

Assets donated with explicit restrictions regarding their use and contributions of cash that must be used to acquire property and equipment are reported as restricted support unless those restrictions are met in the same fiscal year as the related donation. Absent donor stipulations regarding how long those donated assets must be maintained, the School reports expirations of donor restrictions when the School disburses cash to third party vendors for payments to purchase property and equipment that would comply with the purpose of the restricted support. The School reclassifies temporarily restricted net assets to unrestricted net assets at that time.

Deferred Income and Tuition Revenue – Deferred income consists primarily of cash received from local school districts in advance of services being performed. Deferred income is adjusted and tuition revenue is recognized as services are performed.

Accrued Rent Expense – Rent is recognized on a straight-line basis over the life of the lease.

Use of Estimates – The preparation of financial statements in conformity with United States generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates and it is reasonably possible that the recorded amounts or related disclosures could significantly change in the near future as new information becomes available.

Certain significant estimates used in the preparation of these financial statements include establishing no reserve for accounts receivable, and the determination of useful lives of property and equipment. These estimates are based on management's past experience with regard to the reserve for receivables and useful life determinations.

Concentrations – The School relies heavily on local school districts in the Chicagoland area for placement of children at the School, and for funding for the School's programs.

Depreciation expense charged to operations for the year ended June 30, 2017, was \$12,271 (\$13,036 for the year ended June 30, 2016).

4. Debt

The School has entered into a line of credit with a bank with an available line of \$150,000. There was no balance on this line of credit at June 30, 2016 or 2017. The line matures in May 2019. Interest on the line of credit is payable at the bank's prime rate, which was 4.25% at June 30, 2017 (3.50% at June 30, 2016). The line is subject to covenants that include maintaining minimum cash balances held at the bank and the line is secured by all assets of the School.

There was no interest paid or expenses related to the School's debt agreement during the year ended June 30, 2017 and June 30, 2016.

5. Operating Lease Commitments

The School leases office space at 2353 Hassell Road in Hoffman Estates, Illinois. The lease requires a rent deposit of \$60,000 and the lease term ends in September of 2022. The School has the option to renew the lease for two additional five-year terms subject to conditions as detailed in the lease.

In addition, the School leased a copier through a lease agreement that was scheduled to expire on October 31, 2017. The School terminated this lease in September 2016 and entered into a new lease for a copier on August 30, 2016. The new lease expires on August 31, 2021.

Total rental expense under the office lease and the copier lease was \$293,885 and \$19,546, respectively during the year ended June 30, 2017 (\$273,079 and \$12,757 respectively for the year ended June 30, 2016).

6. Retirement Plan

The School has provided for a qualified defined contribution retirement plan under Section 401(k) with salary deferral provisions which was established in 2010. Under the Plan, all employees of the School at the date of hire are eligible to participate for purposes of salary deferrals and employer discretionary contributions. No employer discretionary contributions to the Plan were made during the year ended June 30, 2017 or 2016.

7. Concentration of Credit Risk

Deposit accounts at an institution are insured by the Federal Deposit Insurance Corporation (FDIC) up to \$250,000. At June 30, 2017, there was \$579,415 maintained in excess of FDIC insured limits. At times during the year, balances in bank accounts may exceed FDIC insurance limits.

8. Contingency

The School has received significant financial assistance from various school districts based on a daily rate approved by the Illinois Purchased Care Review Board, which is subject to review and amendment by that agency. Furthermore, the School is subject to examinations related to licensing requirements and programmatic content by various governmental agencies. Any adjustments to the daily rate or disallowed cost claims resulting from such audits and examinations could become a liability. The School's management believes that the School is in compliance with applicable laws and regulations.

9. Income Taxes

The School has been determined by the Internal Revenue Service to be exempt from federal income tax except for unrelated business income under Section 501(c)(3) of the U.S. Internal Revenue Code and exempt from Illinois income tax under the comparable state law. The School did not have any unrelated business income during the year ended June 30, 2017 or 2016. Accordingly, no provision for income tax has been established.

The Organization's 2014, 2015, and 2016 annual informational returns filed with the Internal Revenue Service and the State of Illinois are open to examination.

10. Subsequent Events

Subsequent events have been evaluated through November 2, 2017, which is the date the financial statements were available to be issued.
